4. Angangen rongorong me chosani ewe leenien kapwung a fori an epwe alisi chon angang lon ewe leenien kapwung me lon ar angangen apwungupwung.

Ewe OLA epwe awora ena list ngeni chon angangen eweleenien kapwung me aramas meinisin. Ekkewe chon chiyaku repwe sain lon ar tipeu ren minne a mak lon CJD 05-05, ewe Continuing Education and Professional Practice Policy for Interpreters, pwe repwe mumuta le fori angangen chiyaku.
