#### II. Approval of Minutes

The January 19, 2024 minutes were approved as submitted.

#### III. Announcements from the Chair

Chair Judge Harris stated that a proposal on the gender-neutral rule project will be submitted to the Colorado Supreme Court for their consideration. Once the court provides feedback, the committee can tackle the project.

#### IV. Business

#### A. Legislative Subcommittees

#### i. HB23-1151 (Judge Gerdes, Kevin McGreevy, and Johanna Coats)

The subcommittee presented proposed amendments at the January meeting. After a productive discussion, the subcommittee agreed to incorporate members'

feedback. The subcommittee believes additional investigation is needed regarding Rule 5. Committee members noted that more specific language to help build uniformity among the jurisdictions would be helpful. Judge Gerdes recommended that the subcommittee gather feedback from the chief judges of the various judicial districts, and she agreed to initiate that process and report back to the committee.

#### ii. HB23-1182 (Judge Nichols, Sheryl Berry, and Magdalena Rosa)

The subcommittee is unsure whether amendments to any rules would promote clarity or would only increase confusion. A Chief Justice Directive (CJD) that covers this area may be updated soon, and the revisions may eliminate the need to amend the rules. For the time being, the subcommittee is suggesting no rule changes. This may be revisited if the CJD is updated.

# iii. SB23-254 (Abe Hutt, Judge VanGilder, and Christian Champagne)

The subcommittee suggested some language fixes to Crim. P. 41 to address the legislative changes. Following some clarifying questions by the committee, the subcommittee will return with a further refined proposal.

#### iv. HB23-1187 (Matt Holman, Judge Vigil, and Karen Taylor)

At this point, the subcommittee believes it is possible that Crim. P. 35 may require changes as a response to the legislation. The subcommittee will discuss and return with a proposal for the committee's consideration.

#### v. Crim. P. 49 Letter from Clean Slate (Judge Harris)

Clean Slate Colorado, a coalition comprised of several non-profit organizations, sent a letter to the committee requesting a rule change to Crim. P. 49(c) to include an exception to the mailing requirement for sealing orders entered under the automated sealing process. Judge Harris formed a subcommittee to consider this issue further. Judge Malone, Sheryl Berry, Abe Hutt all volunteered.

The committee adjourned at 2:25 pm.
