# FISCAL YEAR 2025 PERFORMANCE PLAN

**NOVEMBER 1, 2024**

The legitimacy of government depends on the fair, impartial, and reliable administration of the laws. Courts serve the people of the state by resolving disputes, protecting individual rights and the public interest, and delivering justice in criminal and civil cases. To ensure a just society, courts must tailor the fair, effective, and efficient delivery of justice to fit each individual case.

For citizens to trust the judicial system they must believe that justice is truly for all. The courts are a fundamental government service and should be easily accessible by the public. The Department's recently revised Mission Statement below embodies the important work of courts and probation and their fundamental function in Colorado.

### **Mission**

The Judicial Department works to provide equal access to justice, contribute to public safety, and strengthen the rule of law across Colorado. Together our courts and probation departments are committed to impartial and timely dispute resolution; support for families, litigants, and victims; client rehabilitation; and meaningful community engagement.

**AUTHORITY:** The authority for Colorado's Courts is at Article VI, Colo. Const. and §13-4-101, C.R.S.; and for Probation Services is at §§18-1.3-201 and 18-1.3-202.

## ***Major Functions of the Department***

### ***COLORADO SUPREME COURT***

The Colorado Supreme Court is the state's court of last resort. Decisions are binding on all other Colorado state courts. The Supreme Court is composed of seven justices who serve ten-year terms, and the Chief Justice is selected from the membership of justices. The Chief Justice also serves as the executive head of the Colorado Judicial System and is the ex-officio chair of the Supreme Court Nominating Commission. The Chief Justice appoints the Chief Judge of the Court of Appeals and the Chief Judge of each of the state's 22, soon to be 23, judicial districts (including Denver Juvenile and Denver Probate, which are separate courts in the 2<sup>nd</sup> Judicial District, each with their own Chief Judge) and is vested with the authority to assign judges (active or retired) to perform judicial duties. The Chief Justice and the Supreme Court appoint the State Court Administrator and oversee the work of the State Court Administrator's Office.

Requests to review decisions of the Colorado Court of Appeals constitute a majority of the Supreme Court's filings. The Supreme Court also has direct appellate jurisdiction over cases in which a statute has been held to be unconstitutional, cases involving decisions of the Public Utilities Commission, writs of habeas corpus, cases involving adjudication of water rights, summary proceedings initiated under the Election Code, and prosecutorial appeals concerning search and seizure questions in pending criminal proceedings. All of these appeals are filed directly with the Supreme Court and bypass the Court of Appeals. The Supreme Court also has exclusive jurisdiction to promulgate rules governing the administration of all courts and the practice and procedure in civil and criminal actions.

Colorado's attorneys are licensed and disciplined by the Supreme Court. The court's attorney regulation system helps the Colorado Supreme Court regulate the practice of law in Colorado through various programs. The Office of Attorney Regulation Counsel oversees attorney admissions, attorney registration, mandatory continuing legal and judicial education, attorney diversion and discipline, regulation of the unauthorized practice of law, and inventory counsel. In addition, the court oversees the Board of Continuing Legal Education, and the Board of Law Examiners.

### ***COLORADO COURT OF APPEALS***

The Colorado Court of Appeals is the state's intermediate appellate court and consists of 22 judges who serve eight-year terms. The Court sits in three-member divisions to decide cases. The mission of the Court of Appeals is to provide the citizens of Colorado with clear, impartial, and timely resolutions of appealed orders and judgments as provided by law. The Court of Appeals has initial jurisdiction, with exceptions, over appeals from the Colorado District Courts, Denver Probate Court, and Denver Juvenile Court. In addition, the Court of Appeals has appellate jurisdiction over decisions originating from several state administrative boards and agencies. The Colorado Supreme Court hears appeals of decisions from the Court of Appeals.

## ***COLORADO TRIAL COURTS***

Established pursuant to Article VI of the Colorado Constitution, Colorado's state trial courts consist of county courts, district courts, and water courts. Colorado is divided into 22 judicial districts. However, in January 2025, a 23<sup>rd</sup> Judicial District will be established consisting of Douglas, Elbert and Lincoln counties. Arapahoe County will remain as the 18<sup>th</sup> Judicial District. District boundaries generally align with county borders and can include anywhere from one to seven counties. As of January 2025, there will be 197 district judges serving within Colorado's 23 judicial districts. District judges preside over felony criminal matters, civil claims in any amount, juvenile matters (including adoption, dependency and neglect matters, juvenile delinquency, and paternity actions), probate, mental health, divorce proceedings, and water cases. Additionally, district judges handle appeals from Colorado municipal and county courts, and review decisions of some administrative boards and agencies. Within the 2<sup>nd</sup> Judicial District, Denver Juvenile and Denver Probate courts operate independently from the District Court. These two courts have limited jurisdiction over juvenile and probate matters respectively. Each of the State's 23 Judicial Districts (and Denver Juvenile and Denver Probate courts) also has a Court Executive and a Chief Probation Officer, and each of the 64 counties has a Clerk of Court.

Colorado's county courts serve the citizens of each county in the state. Colorado's 114 county judges handle cases involving serious public safety issues such as misdemeanor cases, felony advisements, setting bonds, and preliminary hearings. County judges and magistrates also issue restraining orders in cases involving domestic violence, issue search warrants, and preside over traffic cases and civil actions involving no more than \$25,000.

The Water Right Determination and Administration Act of 1969 created seven water divisions according to drainage patterns of Colorado's major water basins. Each water division is staffed with a division engineer, appointed by the state engineer; a water judge, appointed by the Supreme Court; a water referee, appointed by the water judge; and a water clerk, assigned by the district court. Water judges are district judges appointed by the Supreme Court and have jurisdiction in the determination of water rights, the use and administration of water, and all other water matters within the jurisdiction of the water divisions.

## ***PROBATION SERVICES***

Adult and juvenile probation supervision is provided in all 23 of Colorado's judicial districts. This includes 24 probation departments with over 70 separate probation offices throughout the state. Probation also provides victim services and writes presentence investigation reports for Colorado's Courts. Probation continues to work to identify and utilize assessments, processes, and programs that enhance public safety, are cost effective, and lead to positive outcomes for the probationer and the community.

## ***OFFICE OF THE STATE COURT ADMINISTRATOR***

Colorado Courts and Probation, with more than 300 judges and 3,600 support staff members, is centrally administered by the Chief Justice of the Supreme Court. To assist the Chief Justice, the Supreme Court appoints the State Court Administrator (SCA).

The State Court Administrator's Office (SCAO) provides administrative support and services to the trial courts, appellate courts, and probation to assist them in providing the citizens of Colorado meaningful, speedy, and economical forums to resolve disputes. It also supports the management of probation services to enhance public safety and offender rehabilitation.

In executing its constitutional and statutory duties, the office has the following functions: to provide administrative and technical support to the appellate courts, trial courts and probation; to provide centralized policy guidance; to develop and implement standards and guidelines; to serve as an advocate in obtaining necessary resources from the legislature; to provide services in an accurate, timely and equitable manner. Business processes and technologies are consistently under evaluation for improvements throughout the Department to improve efficiency and to make the courts more accessible to all.

## Key Principles & Goals

### **PRINCIPLE 1: Provide equal access to the legal system and give all an opportunity to be heard.**

*Barriers to access range from difficulties navigating court and probation facilities to a lack of information on how to obtain accommodations for people with disabilities or those with limited English proficiency to inadequate resources to assist self-represented parties with their procedural questions. Such barriers may compromise effective and meaningful access to the court system.*

**GOAL 1a. Identify and address barriers to effective participation.**

**GOAL 1b. Maintain safety in all court and probation facilities.**

**GOAL 1c. Assist self-represented parties.**

### **PRINCIPLE 2: Treat all with dignity, respect, and concern for their rights and cultural backgrounds, and without bias or appearance of bias.**

*As Colorado's population continues to diversify, so does the population that participates in the court system. It is important that judges and judicial staff be aware of the values of a wide number of cultures and life experiences, and, when appropriate, make accommodations. Courts and Probation are working to ensure that the courts are free from both bias and the appearance of bias, meeting the needs of increasing numbers of self-represented litigants, remaining receptive to the needs of all constituents, ensuring that court procedures are fair, understandable and accessible, and providing culturally responsive programs and services.*

**GOAL 2a. Collect feedback from court users, victims of crime, and those on probation regarding their experience with court and probation services.**

**GOAL 2b. Train all court and probation employees in communication, cultural competency, and customer service skills.**

### **PRINCIPLE 3: Promote quality judicial decision-making and judicial leadership.**

*Court practices and case management procedures should be as uniform as practicable to avoid confusion and uncertainty. Courts and Probation must provide ongoing professional development, education, and training to address many concerns including the increasing complexity of court practices and procedures in court operations and interactions with the public. Maintaining professional excellence will promote public trust and confidence in the judicial system as a whole.*

**GOAL 3a. Employ effective case management strategies.**

**GOAL 3b. Incorporate evidence-based principles in judicial decision-making.**

**GOAL 3c. Employ accountability methods to ensure court orders are being enforced and monitored.**

**GOAL 3d. Develop systems that assure court-appointed persons are providing quality services.**

**GOAL 3e. Train and educate judicial officers on an ongoing basis.**

**GOAL 3f. Implement professional development and leadership programs for staff.**

### **PRINCIPLE 4: Implement quality assessments and community supervision of adult and juvenile probationers to demonstrably enhance public safety and respect for victim rights.**

*The Division of Probation Services strives to reduce offender recidivism through the application of the Eight Principles of Effective Intervention<sup>1</sup>. Probation Services promotes accountability and responsiveness in its enforcement of the court's orders while affecting long-term behavior change in offenders.*

**GOAL 4a. Ensure the accuracy and efficiency of pre- and post-sentence assessments; and provide comprehensive assessment information to assist judicial officers in making more informed decisions, leading to improved and less costly outcomes.**

**GOAL 4b. Employ evidence-based practices in all applicable areas of probation.**

***PRINCIPLE 5: Cultivate public trust and confidence through the thoughtful stewardship of public resources.***

*In serving the people of Colorado, Courts and Probation must also exercise appropriate constitutional and statutory authority and responsibility to plan for, direct, monitor, and support the business of the system and to account to the public for the system's performance. The fulfillment of this role is only possible when the other branches of government and the public have trust and confidence in the system. In order to retain trust and confidence, the system must be accountable to the people it serves by providing a fair and open process, communicating clear and consistent expectations for all who participate in that process, and being good stewards of the resources appropriated to it for the fulfillment of its mission.*

**GOAL 5a. Utilize the most effective and cost-efficient methods to conduct the business of the courts and probation.**

**GOAL 5b. Employ new and enhanced technology solutions for managing judicial business.**

**GOAL 5c. Share information and data with other governmental entities and the public, while balancing privacy and security concerns.**

**GOAL 5d. Ensure transparency of court and probation services operations.**

**GOAL 5e. Maintain a strong and well-trained workforce.**

## *Environmental Scan*

In Fiscal Year 2024 (FY24), the Judicial Department demonstrated its dedication to driving technological innovation and strengthening partnerships to improve the accessibility, efficiency, and security of judicial operations. The Department continued its work to establish the new 23<sup>rd</sup> Judicial District. The Department also made a strategic investment by updating workload models for trial courts and the Court of Appeals (COA), ensuring accurate data-driven resource allocation. Additionally, the Department has an ongoing commitment to pursuing long-term solutions to enhance the security and functionality of virtual hearings. Our efforts include securing the necessary funding for critical improvements to ensure a safe, secure, and robust virtual hearing platform; making substantial progress in overhauling the outdated case management system to better support modern judicial needs; launching a fully redesigned, accessibility-compliant judicial website; and implementing numerous critical legislative mandates, including the statewide sealing of criminal records.

### **Implementation of 23<sup>rd</sup> Judicial District**

On January 14, 2025, Douglas, Lincoln, and Elbert counties will separate from the 18<sup>th</sup> Judicial District to become the 23<sup>rd</sup> Judicial District. This change was created by HB20-1026. Colorado voters passed Amendment D during the 2022 election, allowing the Governor to assign judges from the current 18<sup>th</sup> Judicial District to the 23<sup>rd</sup> to ensure continuity. The Governor will make these assignments by November 2024. The Chief Justice appointed an Administrative Judge of the current 18<sup>th</sup> Judicial District to lead the transition of services and administrative support for the new 23<sup>rd</sup> Judicial District. The Administrative Judge led the hiring process for a new leadership team, including a Court Executive and Chief Probation Officer. The leadership team finalized its FY25 budget and completed testing information technology and financial systems. The leadership team has also coordinated with SCAO on auditing for these systems to ensure they are prepared for the transition. A Problem-Solving Court Steering Committee has also been created and has begun planning for the transition of clients to the new judicial district. The Judicial Department, in consultation with the Governor's Office, has identified the need for cleanup legislation regarding the appointment terms for the 23<sup>rd</sup> Judicial District Judicial Performance Commission, and will work with the General Assembly on cleanup legislation.

### **Workload Studies**

Over the last two years, the Judicial Department made a significant investment in completing comprehensive workload studies for the district court bench, county court bench, court staff, and the Court of Appeals, marking a critical step toward understanding the current resource landscape for judicial officers and trial court staff. These updated workload models provide an accurate, data-driven reflection of the demands placed on the judicial system, revealing that current workloads have increased in complexity; consequently, the work of the courts is becoming unsustainable without additional resources. By highlighting the gap between the available capacity and the workload demands created by a complex caseload, the models underscore the urgent need for strategic investment to ensure timely access to justice, maintain judicial quality, and support the well-being of court staff. This

effort not only strengthens the Department’s ability to advocate for resources but also ensures a transparent and accountable approach to meeting the needs of the communities it serves.

#### District Judicial Officer Model

The District Judicial Officer Study, initiated in April 2022, included a time study conducted from September 19 to October 16, 2022. The updated report highlights a critical imbalance between the current workload and the current judicial capacity. Case weights—measuring the average time required to handle each case—have increased significantly across several case types, including civil, domestic relations, mental health, juvenile, and criminal matters. This reflects both the rising complexity of cases, such as family law disputes and felony criminal cases, and the evolving demands placed on the judiciary. Legislative and procedural changes over the past decade have further compounded these challenges, increasing the time and resources needed to process cases. For example, the adoption of juvenile case processing "best practices" requires significantly more judicial attention, while recent legislative mandates have introduced additional hearings in mental health cases. These findings underscore the urgent need for additional judicial resources to ensure timely, effective, and equitable resolution of cases.

#### County Judicial Officer Model

The County Judicial Officer Study, launched in July 2023, included an official time study conducted from January 29 to February 25, 2024. The updated report reveals that the current workload exceeds the capacity of the existing 108 full-time equivalent (FTE) judicial officers statewide. Notably, case weights—measuring the average time required to handle each case—have risen significantly since the last study in 2018, particularly for county civil, small claims, traffic, misdemeanor, and protection order cases. This increase reflects the growing complexity of cases, which now require more time and resources to ensure proper resolution, further underscoring the urgency of addressing resource shortfalls to maintain effective and equitable judicial services.

#### Trial Court Staff Model

The Court Staff Study, launched in April 2023, included a time study conducted from September 25 to October 22, 2023. The study examined the workload of general case processing staff and four specialized roles: Family Court Facilitators, Problem-Solving Court Coordinators, Protective Proceedings Monitors, and Self-Represented Litigant Coordinators. For the first time, Collections Investigators also participated in the workload study, which resulted in an initial workload model for this group of staff. The updated report reveals a critical staffing shortfall. Significant increases in case weights—reflecting the average time required per case—were observed compared to the previous 2017 study, particularly for district civil, domestic relations, and juvenile dependency and neglect cases, as well as county civil, small claims, traffic, misdemeanor, and protection order cases. These increases are driven by the growing complexity of cases, especially in areas such as domestic violence and juvenile delinquency, which demand more time and resources for proper management. Moreover, increasing administrative responsibilities, including running and reviewing data integrity reports and providing customer service to pro se litigants, have significantly expanded non-case-related workload, further straining staff capacity. These findings underscore the urgent need for increased staffing to ensure effective case processing and maintain the high standards of service required by the judiciary.



### Court of Appeals Model

The Court of Appeals Study, initiated in September 2022, included a time study conducted from January 23 to February 19, 2023. The study highlighted a pressing need to address the increasing workload and recommended that the Colorado Court of Appeals (COA) expand by adding additional panels and more staff support in key positions to ensure continued efficiency in case processing and maintain the current level of support. Key drivers of this increased demand include a significant rise in the number of criminal direct appeals filed since the COA's last expansion in 2008. This increase in certain cases, coupled with their growing complexity, has placed immense pressure on the existing judicial staff and resources.

### **Disruption of Virtual Hearings**

The Judicial Department conducts over 95,000 hearings each month, the majority of which are held virtually or in a hybrid format to facilitate remote participation. To support this, the Department manages approximately 475 virtual rooms, which serve as both hybrid and fully virtual courtrooms. Due to the speed at which virtual hearings were adopted during the pandemic, the Department had to adapt by using available professional meeting platform technology (Webex). While this technology has been successful in providing a place for case participants to meet, it has been unable to provide features that are necessary to truly manage a virtual courtroom. The features include but are not limited to user identification and management, robust controls for managing the audio and video available in the virtual courtroom, and more rigorous information security controls. These features are increasingly necessary as the digital landscape evolves and changes.

Recently, the lack of virtual courtroom management tools is being exploited by individuals joining virtual court proceedings to display and speak content that is violent, racist, pornographic, vulgar, and inappropriate. While the Department has faced such disruptions before, the scale and sophistication of these latest incidents are unprecedented. The disruptors are easily circumventing the existing technical controls, exposing significant vulnerabilities to our virtual court system. The Department has submitted a supplemental budget request for a new digital court solution to address these problems and ensure safe and reliable virtual court proceedings are available for litigants.

### **New Case Management System Implementation**

The Judicial Department is fully committed to creating a modern, agile case management system (CMS) designed to meet the evolving needs of courts and judicial systems. As a core platform for managing and tracking cases throughout their lifecycle, this new CMS will be an essential tool for streamlining operations, improving efficiency, and enhancing access to justice. It will provide the flexibility and scalability needed to adapt to future demands, ensuring long-term sustainability.

Recognizing the limitations of the current antiquated system—hampered by outdated technology and unsustainable customizations—the Judicial Department has prioritized replacing it with a solution that lowers the total cost of ownership, enhances customer access, and optimizes workforce efficiency. To

achieve this, the Department has partnered with a consulting firm to conduct a comprehensive assessment of its data and workflows across all judicial districts.

In the past quarter, significant progress has been made. Consultants have begun identifying and classifying data and job shadowing in select districts to understand daily operations. Over the next quarter, interviews with stakeholders across all judicial districts will further refine the system's design. To date, over 1,000 workflow processes have been documented, laying the groundwork for a dynamic CMS that will transform court operations and support the Judicial Department's mission of delivering accessible, efficient justice for all.

### **Accessibility and Implementation of House Bill 21-1110**

The Judicial Department is in the implementation process of a multi-phase plan to meet the requirements of House Bill 21-1110 (HB21-1110), Colorado Laws for Persons with Disabilities. Currently, under the Colorado Antidiscrimination Act (CADA), it is unlawful for any person to discriminate against an individual with a disability. HB21-1110 added new language that specifically applies this standard to government information technology and expands the state's information technology accessibility standards to include all individuals with disabilities, as defined by the ADA, instead of just people with visual challenges. All technology, both hardware and software, that is both public-facing and internal-facing including any technology provided by or procured by a government entity that is used by the public or used by a government entity employee is subject to these new requirements. This includes websites, applications, kiosks, digital signage, documents, video, audio, and third-party tools. The Office of Information Technology (OIT) has statutory authority in C.R.S. 24-85-101 to establish statewide accessibility standards that all state agencies, including Judicial, had to comply with by July 1, 2024. The Judicial Department provides services to constituents through online services, applications, and third-party tools. The Judicial Department was not adequately prepared, skilled, or budgeted for the digital transformation necessary to comply with HB21-1110 and has been working to update all technology used by judicial districts, SCAO, and the appellate courts. The scope of changes will impact every employee and member of the public who interacts with the courts or probation. In FY23, a supplemental budget request was approved for contractual help with expertise in the field of accessibility to inventory digital assets, assess remediation needs, and determine training needs for Judicial staff. As a result of this assessment, the Judicial Department has begun making the necessary changes to our technology to meet the new accessibility standards. Systems and information utilized by the public and external partners have been the primary focus thus far along with training and education of judicial staff. In July 2024, the Judicial Department launched a fully redesigned website, marking a significant milestone in its commitment to accessibility and modernization. The new website features a user-friendly interface, improved navigation, and enhanced functionality, making it a more effective tool for public access to judicial resources. By aligning with modern accessibility standards, the redesigned site not only meets the diverse needs of the public but also reflects the Judicial Department's dedication to inclusivity and innovation. As a dynamic platform, it will continue to evolve through collaboration with judicial districts and user feedback, ensuring it remains a cornerstone of accessible and efficient court operations.

Building on the launch of the redesigned website, the Judicial Department has also made significant progress in remediating other critical systems to meet accessibility standards. Accessibility updates have been deployed for platforms that are critical for the public to interact with the judicial system, namely,

the Public Access Terminal and the Colorado State Courts Data Access systems, ensuring these platforms are now compliant and fully accessible. Concurrently, the State Court Administrator's Office (SCAO) Information Technology Services is actively developing accessibility enhancements for court e-filing and court-appointed counsel systems. To support these efforts, internal staff continue to provide dedicated assistance with document remediation through regular office hours. Over the coming months, SCAO will deploy these updates to production while identifying and addressing additional applications in the backlog that require accessibility improvements. These ongoing efforts reaffirm the Judicial Department's commitment to creating a fully accessible technological infrastructure.

## **Sealing of Criminal Records**

The Judicial Department has taken significant steps to implement the automatic sealing of certain criminal records, as outlined in Colorado law (SB22-099). This process aims to give individuals with eligible cases a fresh start by sealing their records without requiring them to take any action.

The first list of potentially eligible cases was shared with the Colorado District Attorneys' Council (CDAC) on February 1, 2024, so district attorneys could review and flag any ineligible cases. Before this step, courts worked together to ensure the list was as complete as possible. However, during the review, it was found that some domestic violence cases that shouldn't qualify for sealing were included due to limitations in how older cases were flagged in the system. To address this, Judicial leadership worked with CDAC to refine the list, ensuring only eligible cases moved forward. The revised list was shared on March 14, 2024, and a 45-day period was provided for objections. Cases without objections were sealed after this period.

A second list followed on July 1, 2024, and a similar process was used to ensure accuracy and fairness. Alongside this effort, the Judicial Department launched a secure webpage on June 11, 2024, allowing individuals to confidentially check if their case was sealed. Additional features, such as helpful links, a glossary of terms, and an instructional video, are being developed to improve understanding and access. Since the implementation of SB22-099, a total of 134,571 eligible cases have been automatically sealed as of September 2024.

The third list was transmitted in October 2024, and cases without objections were sealed shortly thereafter. Looking ahead, starting July 1, 2025, non-drug felony cases will also be included in this process, further expanding the scope of record-sealing efforts. These changes reflect the Department's dedication to fairness and second chances for eligible individuals while ensuring the process remains thorough and transparent.

## **Training in Probation**

The Division of Probation Services (DPS) Professional Development Unit continually works toward meeting the learning needs of Probation. In FY24, 129 probation officers were trained in defensive tactics, tactical awareness, and the constitutional limitations of force. Additionally, 114 new staff were trained in research-informed best practices for effective supervision of probation clients through the Probation Academy. All learning is developed and continually revised with an evidence-based

instructional design approach in mind.

The DPS Professional Development Unit continually seeks to improve upon the ability to meet the learning needs of staff across the state. Probation is experiencing similar challenges to the trial courts with an increase in hiring of new employees and the demand for more training in varied delivery modalities. During the FY24 legislative session three additional staff were appropriated to provide more learning resources in the DPS Professional Development Unit to support probation. This will include a Probation Analyst III that will manage large, complex projects and supervise staff, as well as two additional Education Specialists.

## **Legislative Updates in Probation**

### **House Bill 24-1445**

With the passing of HB 24-1445, the court shall not require a defendant to pay probation supervision fees in more than one case when the probationer is placed on probation in multiple cases. Probation Standards already required each district to have a policy and procedure regarding the recommendation for assignment, collection and request for waiver when supervision fees have been ordered in multiple cases. Unless inconsistent with other conditions imposed by the court, the bill also directed the probation officer to schedule meetings in good faith with individuals on probation at mutually agreeable times that do not conflict with the probationer's essential obligations including work, education, job training, dependent care, medical appointments, and other probation requirements and allows for the probationer to meet with the probation officer through a telephone call or audio-visual communication technology.

### **Senate Bill 24-030**

With the passing of SB24-030, the State Court Administrator's Office appointed a representative to the Division of Criminal Justice work group. The work group is tasked with developing a definition of recidivism by 1/15/25. All state entities will begin using this new definition by 7/1/25.

## Management Strategies and Measurements

### Trial Courts

#### New Case Filings Overview

County court case filings grew 7.4% compared to FY23. Every county case class saw an increase in new cases except for felony complaints in FY24. There were especially large increases in civil and traffic cases.

In FY24, district civil cases (excluding distraint warrant and Rule 120 cases) saw a notable increase of approximately 10% compared to FY23. General juvenile cases grew by a smaller margin of 2.20%, while mental health cases rose by 2.53% during the same period.

# Trial Court Management Strategies

## Case Timeliness Standards

While we are pleased to report improvement in certain categories of case processing, it is important to emphasize that these gains reflect targeted efforts and short-term solutions rather than sustainable, consistent progress. Despite these efforts, the data demonstrates that we continue to fall short of achieving established benchmarks, particularly in a way that aligns with long-term sustainability. As indicated by the updated weighted caseload studies for the county court bench, district court bench, and trial court staff, the shortfall of resources to process cases is likely a significant contributing factor to the increase in case processing time.

## Court User Survey

The court user survey is another ongoing measure the Department uses to assess the trial courts. The survey focuses on procedural fairness, service quality, and ideas for actionable improvements. An updated version of the survey was piloted in five judicial districts (the 1st, 4th, 8th, 9th, and 12th), and then expanded statewide in October 2023. After statewide rollout, 8,443 court users completed the survey in FY24. Survey respondents included parties, attorneys, witnesses, jurors, law enforcement, observers, and others.

Questions included several 5-point Likert-style questions which are represented in table 7 below. Most court users were highly satisfied with the courts, with 75% of court users providing a positive Likert-scale response to a majority of questions, and each Likert-style question received a positive response from more than 65% of court users.

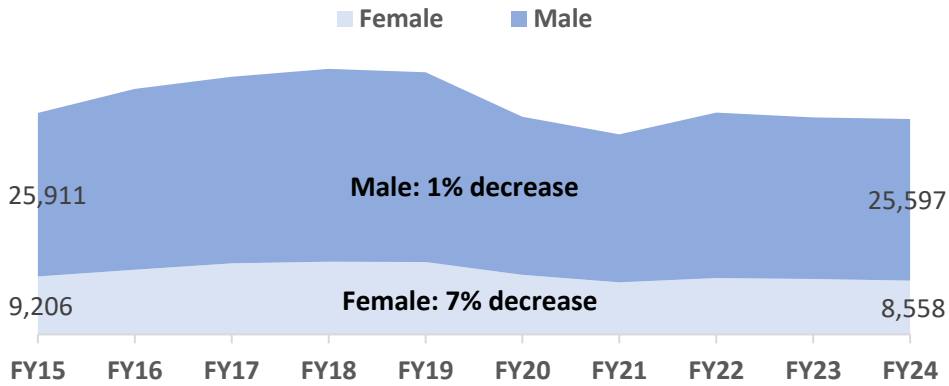
## **Probation Services**

Colorado Probation provides community supervision for adults and juveniles sentenced to probation. Despite Colorado’s general population growth, the number of individuals sentenced to probation, after peaking in FY19, has been trending downward. There were just under 1,000 fewer adults sentenced to probation in FY24 (34,155) compared to FY15 (35,136) and 1,300 fewer juveniles sentenced to probation in FY24 (1,930) compared to FY15 (3,289). After experiencing a sharp decline in probation sentences during the COVID- 19 public health emergency, new sentences to probation have remained steady.

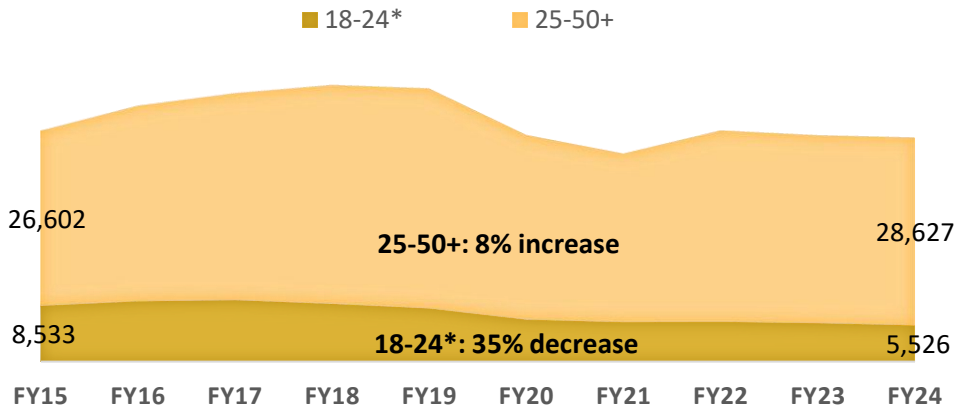
Probation’s population has evolved over the last ten years. For the largest population, adults on regular supervision, the proportion of those with felony and misdemeanor convictions has remained constant. Approximately a third of adults sentenced to probation, in any given year, have a felony conviction. After peaking in FY19 with almost 14,000 adults with felony convictions entering probation (34% of new adult probationers), the number has decreased. In FY24, 10,500 adults were sentenced to probation with a felony conviction (31% of new adult probationers) and just over 23,000 were sentenced to probation with a misdemeanor conviction. It’s likely current population trends reflect a combination of factors including lasting impacts of the COVID-19 public health emergency, statutory changes (e.g., the decriminalization of some drug crimes, changes in theft amounts and impaired driving offenses), and system changes to the juvenile and adult criminal justice system.

Longer-term trends show slight decreases in the total number of new individuals sentenced to probation. Since FY15, the numbers of males and females sentenced to regular probation have decreased, while the percentages of each have remained steady: in FY15, 26% of new, regular adult probationers were female (9,206) and 74% were male (25,911). Similarly, in FY24, 25% were female (8,558) and 75% were male (25,597). Additionally, over the last ten years, the young adult regular probation population has shrunk while the remainder of the adult population (especially 25-50+) has increased. In the last ten years, the number of probationers in the 18-24-year-old category decreased 35% from 8,533 in FY15 to 5,526 in FY24. In contrast, the number of probationers in the 25-50+ range increased 8% from 26,602 in FY15 to 28,627 in FY24.

10 YEAR COMPARISON**



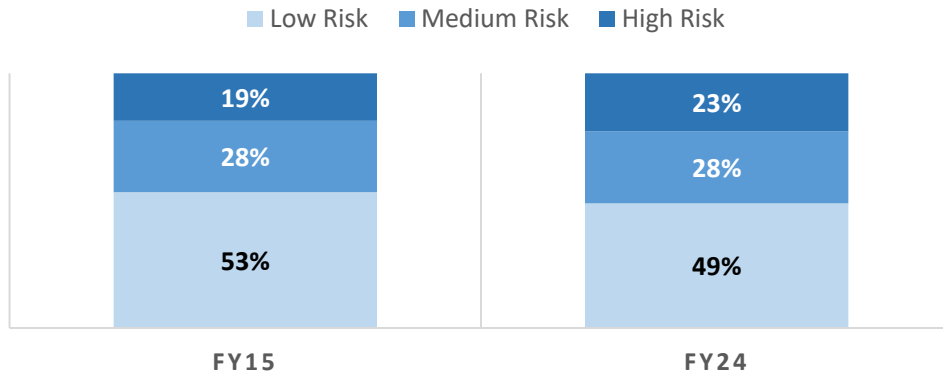
**NEW ADULT PROBATIONERS BY AGE

Alongside the trends highlighted above, probation has experienced shifts in the number and proportion of higher-risk adults on probation supervision. Leadership and staff in probation departments report individuals placed on probation are not only presenting with greater needs but also have more complex and disrupted stability factors (e.g., homelessness, financial), behavioral problems, acute mental illness, and longer histories of failure on community supervision. These cases require greater strategic and time-intensive supervision and so the strain placed upon state probation resources is growing, which exacerbates workload pressures currently felt under existing staffing levels.

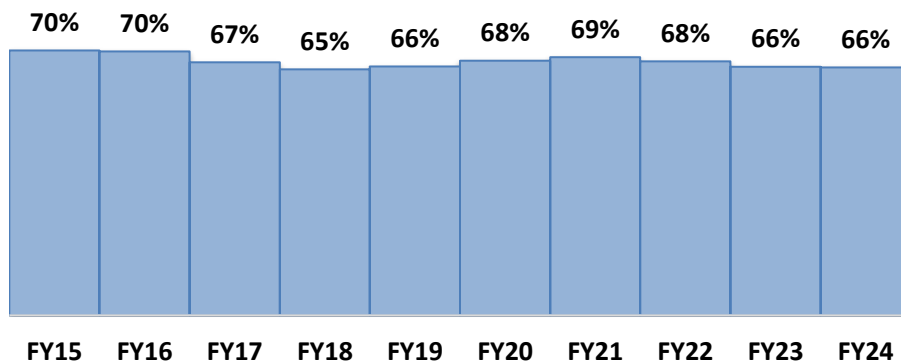
### RISK LEVEL COMPARISON FY15 TO FY24



Probation continues to work to identify and use assessments, processes, and programs that uphold public safety, are cost effective, and increase positive outcomes. There is a consistent focus on the identification and implementation of research-informed practices and principles. This effort is aligned with the principles of evidence-based decision-making and supports the approach of working with individuals based on their unique needs.

Probation success rates have steadily hovered between 66% and 69% over the last 6 years, slightly lower than 70% a decade prior. As adults and juveniles with higher risks and needs enter the criminal justice system, lower success rates can be expected. In FY24, the overall success rate for probation programs was 66%.

House Bill 24-1445 requires the Judicial Department to track the amount of probation supervision fees assessed and the total receipts. This is calculated using the probation supervisor sentence code. Note that the total for receipts is not equal to the total number of persons assessed as receipts may be from payments made outside of fiscal year 2024. In addition, the assessed amount reported may include supervision fees probation departments may intend to waive for reasons such as limited income, early termination, revocation, or if it is discovered the probationer was assessed supervision fees in multiple cases when sentencing occurred on different days or by different courts.

### ***Probation Management Strategies***

To improve outcomes, Probation continues to pursue adequate staffing, implementation of applicable research-informed programs and practices, and training and skill development for staff. Probation’s current efforts to improve outcomes include the following.

New electronic monitoring (EM) vendors and contracts were implemented. The statewide implementation included significant efforts to better educate probation staff and judicial officers—as well as criminal justice stakeholders—on the benefits, realities, and limitations of EM. Additionally, a new Chief Justice Directive (CJD) was executed to increase consistency across jurisdictions regarding the utilization of EM. The CJD outlines the purposes and limitations of EM in probation, as well as addresses numerous procedural requirements.

Probation staff experience a significant amount of occupational stress and secondary trauma due to their work. The COVID-19 public health emergency magnified the stress for these officers, as they had to find creative ways to continue providing services while adhering to public health guidelines and local directives. In addition, the fentanyl epidemic has disproportionately affected individuals on probation, which has added another layer of distress for probation staff. In response, the Division of Probation Services (DPS) has been focusing resources on addressing staff health and wellbeing. Quarterly learning opportunities continue to be offered to Judicial employees with a focus on wellbeing. In addition, DPS has made the Corrections Fatigue to Fulfillment curriculum a part of the regular training catalog and are developing local peer supports to connect with probation staff who engage in the curriculum. This is in addition to local efforts to address this issue. It is hoped that providing these resources will reduce turnover and improve the overall well-being of current employees, so they are better equipped to perform their job duties.

Performance feedback efforts continue, including the development of dashboards and quarterly statistical reports summarizing each judicial district’s current population and termination numbers. These reports provide probation departments with the opportunity to adapt more quickly to changing justice-involved populations and manage resources accordingly.

The Special Projects Program (formerly known as the Rural Initiative Program) continues to facilitate the training and state approval of domestic violence, sex offender and substance abuse treatment providers

in underserved regions. This effort is intended to provide quality treatment “close to home” for probationers who would otherwise be required to travel significant distances to secure treatment. More recently, navigator services have been introduced to assist probationers with successful completion of supervision and the requirements of their sentence. These initiatives are supported by supervision fees paid by offenders.

The Judicial Department continues to participate in an information-sharing agreement with the Department of Health Care Policy & Financing (HCPF). The purpose of the agreement is to improve collaborative relationships at a state and local level with a specific focus on improving access to care and care coordination, reducing recidivism, identifying cost and time saving opportunities, developing evaluations, and using data and information to make decisions. In addition to the information-sharing agreement, improved process and data collection efforts are underway. Probation officers identify individuals who are actively enrolled in Medicaid and this information is reported to HCPF and passed along to the specific HCPF contractors, such as the Regional Accountable Entities (RAEs), that function as the members’ respective healthcare plans. Additionally, the Judicial Department and HCPF established monthly collaborative meetings. These monthly meetings are with Judicial Division of Probation Services (DPS) representatives, HCPF representatives, and Criminal Justice Care Coordinator representatives from each of the RAE regions. The Judicial Department is actively working alongside HCPF and the RAEs to create additional collaboration opportunities at the state and local levels. Local probation districts and RAE regions have scheduled meetings to further support awareness of care coordination resources, Medicaid funding, and the complexities for dually involved people in probation and the behavioral health system.

## *Summary*

In FY24, the Colorado Judicial Department made extensive efforts to exemplify its renewed mission, vision, and values in its work. These efforts are paying off. The court user survey reports 75% of court users surveyed have a positive view of their interaction with the courts. Probation continues to secure high success rates for probationers despite the proportion of high-risk probationers increasing. Overall, the Colorado Judicial Department continues to perform its mission at a high level by providing equal access to justice, contributing to public safety, and strengthening the rule of law.
