

Chief Judge Order 25-01 ADOPTING PRIOR CHIEF JUDGE ORDERS, CHIEF JUDGE ADMINISTRATIVE ORDERS, AND BEST BUSINESS PRACTICES ISSUED FOR THE 18TH JUDICIAL DISTRICT PRIOR TO JANUARY 14, 2025

House Bill 20-1026 separates the existing 18th Judicial District (Arapahoe, Douglas, Elbert, and Lincoln Counties) into the 18th Judicial District (Arapahoe County) and the 23rd Judicial District (Douglas, Elbert, and Lincoln Counties). The effective date of this transition to two separate judicial districts is January 14, 2025. *See* C.R.S. § 13-5-123.2. With the creation of the 23rd Judicial District on January 14, 2025, the undersigned, in her capacity as Chief Judge of the 18th Judicial District, finds it necessary to identify the existing local policies that will be adopted for the new 18th Judicial District.¹

Accordingly, pursuant to Chief Justice Directive 95-01 Authority and Responsibility of Chief Judges, the undersigned, in her capacity as Chief Judge of

To the extent any of the above listed Chief Judge Orders, Chief Judge Administrative Orders, and Best Business Practices include Douglas, Elbert, and/or Lincoln Counties, the applicable document shall only be adopted as it pertains to Arapahoe County.

Additionally, if a Chief Judge Order, Chief Judge Administrative Order, or Best Business Practice is not adopted by this Chief Judge Order 25-01, the undersigned finds that it has served its purpose and does not need to be formally adopted moving forward. In the event the undersigned inadvertently missed adopting an applicable Chief Judge Order, Chief Judge Administrative Order, or Best Business Practice, then the undersigned may issue a supplemental adoption order on a later date. Although not mentioned in this CJO 25-01, all Chief Judge Administrative Orders entered in individual cases (i.e. recusal reassignments, senior judge reassignments, etc.) remain in effect. Similarly, this CJO 25-01 does not impact any board appointments or other appointment orders, even if labeled as a Chief Judge Administrative Order, entered by the Chief Judge that are still in effect.
