a) Forever Links (new)

b) Increased Filing Fees (updated)

Starting January 1st, filing fees increased by \$30 for civil cases in District Court and \$10 for some civil cases in County Court. HB24-1286.

- Many forms and instructions have been updated. Others will be updated as time allows, but the process will likely take several months.
- As a reminder, form JDF 1 was discontinued in November of 2024.
