(Bill Effective Date)

- SB25-129 April 24th
 - This bill now requires those requesting a subpoena to affirm specific facts about that subpoena.
 - Those facts were incorporated into a new affidavit (JDF 80.3) to be attached to a draft subpoena and/or subpoena request.
 - The subpoena forms, instructions, and motions were updated for this new process.
