a) Legislation Updates (new)

(Bill Effective Date)

Below is a list of some legislation going into effect and a summary of form changes.

- HB25-1159 – Child Support Commission Updates May 31st
 - The domestic relations (DR) cover sheet is sealed after filing.
 - Updates to DR cover sheet, return/waiver of service, and response forms are coming soon.
- HB25-1275 – Post-Trial Relief (Crime Lab Misconduct) June 2nd
 - No existing forms updated. [\[Website support\]](#).
- HB24-1133 – Criminal Record Sealing July 1st
 - Litigant can now indicate if they need a language interpreter.
 - Litigant can now indicate if they will appear virtually or in person for hearings.
 - Litigant can file into an existing case to seal multiple cases in the same Judicial District (previously started new CV case).
 - New form series (2370s) will seal convictions where the conduct is no longer prohibited (i.e. marijuana, psilocybin)
- HB25-1168 – Victim-Survivors in Evictions August 6th
 - A repayment plan for missed rent is sometimes required for victim-survivor of certain crimes.
 - 30-day stay to the Writ of Restitution for victim-survivors.
 - Updates to JDFs 91, 99A, 102, 107A, and 109 coming soon.
 - Note: Spanish versions will be pulled until updated.
 - Updates to JDFs 101 and 103 are coming later this year/early 2026.
