Research concerning use of the libraries of the Ninth Judicial District in Glenwood Springs, Aspen, and 1) Meeker, Colorado, has disclosed that ---

From November 1, 2000 to November 1, 2001 an annual sum of \$9,750 was spent for books and supplements for the Garfield County library in Glenwood Springs;

During the same time period, 34 books were checked out, which amounts to \$287 per book;

Assuming five person-visits to the library per checkout, the cost is \$57 per user visit;

We have no remaining volunteers to help the clerk staff to maintain the library;

The books and supplements are not up to date, and many are still packaged inside cartons or boxes;

Pitkin County uses CD-rom disks, and they cost \$896 per month, or \$10,757 annually;

For Pitkin County, it is estimated that there are 12 to 24 uses per month usage at a cost of \$215 to \$500 per

use;

In Meeker, only the Colorado Reporter is current;

The Meeker library space has been converted to a chambers;

There is little use of the books, and they are obsolete.

- Extensive efforts by the Clerk of the Court to sell or otherwise dispose of the books for payment have been 2) unsuccessful, and there are no known buyers.
- The attached list designates those volumes that will be retained, to be located in Room 402 of the Garfield County Courthouse, and those that will be removed. Therefore, the publications designated on the attached list as "Publications to be Removed" shall be disposed of within 90 days. Members of the Bar Associations or any member of the public shall be given an opportunity to take away within 30 days any of the volumes to be disposed
