Note 1: As Alternate Water Judge, Judge Boyd shall be responsible for any water case matters assigned to him by Water Judge Petre. With respect to water assignments, this administrative order simply confirms the status quo. The Water Judge is appointed by the Chief Justice, and the Water Judge has the authority to make assignments in water cases.

Note 2: Until such time as new Judge Nichols' open CR caseload is equal

to the caseload of Judges Petre and Lynch, new CR cases in Garfield County shall be assigned on a 2-1-1 basis; two cases to Judge Nichols; one to Judge Petre; one to Judge Lynch: two to Judge Nichols; one to Judge Petre; one to Judge Lynch; and so on. When the caseloads become equal, the assignment shall thereafter proceed on a 1-1-1 basis.

Note 3: The CR, JV and JD dockets in Rio Blanco County shall be assigned on a rotating basis. Judge Petre is assigned to these dockets for the period July 1-December 31, 2008. Thereafter, these dockets shall be rotated among Judges Boyd, Lynch and Nichols in 6-month segments. The dockets are assigned to Judge Lynch for the period January 1 through June 30, 2009; Judge Boyd for the period July 1 through December 31, 2009; Judge Nichols for the period January 1 through June 30, 2010; and the rotation shall thereafter continue in sequence. When a CR, JV or JD matter is ready to be set for a hearing or trial inappropriate for setting on a docket day, the hearing or trial shall be set on the calendar of the judge in the Rio Blanco rotation at the time of the setting.

Note 4: Magistrate Hernandez is assigned to all Child Support Enforcement cases in the District. All DR matters shall be assigned to a District Judge as set forth above; however, all DR matters initially shall be directed to the Family Court Facilitator and then to Magistrate Hernandez. Magistrate Hernandez may hear all matters in DR cases and JP cases to the extent permitted by C.R.M. 6 and statute. Upon the request of a party or as required by C.R.M. 6 and statute, Magistrate Hernandez or the Family Court Facilitator will refer such cases to the assigned District Judge for further proceedings.

Rio Blanco CV, DR and PR Cases: These cases will be assigned as filed on a 1-1-1 basis to the District Judges hearing these cases. Without regard to the Judge of assignment, routine matters or short hearings which may be heard on a regular Meeker docket day shall be set on the docket day as time permits and shall be heard by the Judge then sitting in the Rio Blanco rotation.

Magistrates Hernandez and Leoniak may also hear such other matters as may from time to time be assigned to them by the Chief Judge.

Existing cases will be reassigned to new Judge Nichols by separate order.
