CHARGES: 4

COUNT 1: MURDER IN THE FIRST DEGREE, C.R.S. 18-3-102(1)(f) (F1){01018}

COUNT 2: CHILD ABUSE RESULTING IN DEATH, C.R.S. 18-6-401(1)(a),(7)(a)(I) (F2){17019}

COUNT 3: TAMPERING WITH A DECEASED HUMAN BODY, C.R.S. 18-8-610.5 (F3){26065}

COUNT 4: TAMPERING WITH PHYSICAL EVIDENCE, C.R.S. 18-8-610(1)(a) (F6){26062}

Daniel H. May, District Attorney for the Fourth Judicial District, of the State of Colorado, in the name and by the authority of the People of the State of Colorado, informs the court of the following offenses committed, or triable, in the County of El Paso:

COUNT 1-MURDER IN THE FIRST DEGREE (F1)

On or about January 27, 2020, Letecia Stauch unlawfully, feloniously, and knowingly caused the death of Gannon Stauch, a child who had not yet attained twelve years of age, and the defendant was in a position of trust with respect to the victim; in violation of section 18-3-102(1)(f), C.R.S.

COUNT 2-CHILD ABUSE RESULTING IN DEATH (F2)

On or about January 27, 2020, Letecia Stauch unlawfully, feloniously, knowingly, or recklessly caused an injury to, or permitted to be unreasonably placed in a situation that posed a threat of injury to, the life or health of a child, namely: Gannon Stauch, and engaged in a continued pattern of conduct that resulted in cruel punishment, or mistreatment, that resulted in the death of the child; in violation of section 18-6-401(1)(a),(7)(a)(I), C.R.S.

COUNT 3-TAMPERING WITH A DECEASED HUMAN BODY (F3)

On or about January 27, 2020, Letecia Stauch, believing that an official proceeding was pending, in progress, or about to be instituted, and acting without legal right or authority, unlawfully and feloniously willfully destroyed, mutilated, concealed, removed, or altered a human body, part of a human body, or human remains with intent to impair its or their appearance or availability in the official proceedings; in violation of section 18-8-610.5, C.R.S.

COUNT 4-TAMPERING WITH PHYSICAL EVIDENCE (F6)

On or about January 27, 2020, Letecia Stauch, believing that an official proceeding was pending or about to be instituted, and acting without legal right or authority, unlawfully and feloniously destroyed, mutilated, concealed, removed, or altered physical evidence with intent to impair its verity or availability in the pending or prospective official proceeding; in violation of section 18-8-610(1)(a), C.R.S.

All offenses against the peace and dignity of the people of the State of Colorado.
