<b>D-18</b> <b>MOTION TO APPOINT DR. JACKIE GRIMMETT TO PERFORM THE SECOND COMPETENCY EVALUATION AND TO APPROVE PAYMENT FOR THE EVALUATION</b>	

Counsel requests that this Court appoint Dr. Jackie Grimmett to perform the second competency evaluation and to approve payment for Dr. Grimmet.

1. Ms. Stauch, through Counsel, requests a second competency evaluation under C.R.S. 16-8.5-103(4), (2020).
2. Defense Counsel has contacted Dr. Jackie Grimmett to conduct the second competency evaluation. Dr. Grimmett has agreed to conduct a second competency evaluation.
3. Defense Counsel requests that this Court find that Ms. Stauch is indigent and without funds to employ competency evaluators under C.R.S. 16-8.5-107, (2020).

5. Pursuant to the Supreme Court of Colorado Chief Justice Directive 12-03, mental health professionals conducting competency evaluations may be paid a reasonable amount to not exceed \$150 per hour for a maximum of ten hours. In addition, the competency evaluator may be compensated for travel time at a rate of 50% of the authorized hourly rate, not to exceed six hours.
6. Defense counsel requests that this Court appoint Dr. Grimmatt to perform the second evaluation. Defense counsel requests Dr. Grimmatt be compensated at a rate of \$150 per hour. Dr. Grimmatt estimates that conducting the second evaluation with Ms. Stauch, reviewing the records, and writing the second competency evaluation will take approximately twenty hours.
