- I, Cy Gillespie, being first duly sworn, depose and state as follows:
- 1. I am over the age of eighteen years.
- 2. I am a Commander int the El Paso County Jail's Security Division and am employed by the El Paso County Sheriff's Office. My office is currently located at the El Paso County Criminal Justice Center, 2739 E. Las Vegas St., Colorado Springs, CO 80906.
- 3. On April 2<sup>nd</sup>, 2021, at about 2025 hours, I entered the jail cell of Inmate Letecia Stauch to personally notify Inmate Stauch that her refusal to attend the law library program would result in suspension of the privilege.
- 4. Although Ms. Stauch knows who I am, I identified myself to her, as I was in civilian attire and was wearing a KN 95 respirator mask. I told her I really wanted her to take advantage of the law library program she'd refused to attend recently. Ms. Stauch repeatedly said for me to "...take me off the (law library) list..." and that she didn't need the law library. I told her the refusal to attend would result in suspension of her law library privileges for 90 days.

- 5. Ms. Stauch stated her reason for refusing to attend during the hours we'd specified for her was because of medical concerns. She was concerned that her drowsiness would interfere with the early morning hours of her law library slots. I told Inmate Stauch our medical staff could address her medical concerns to better fit with her assigned law library schedule. Inmate Stauch began to argue about her specific medical circumstances and asked if I expected her to "...sleep all day...." I again told her it was in her best interest to participate in the law library program as a pro se inmate and we could address her medical concerns to work with her law library times. She again said she didn't need the law library, thanked me for my help, and told me to take her off the law library list a third time.
- 6. Further affiant sayeth naught.
